*Once registration documents and remittance received by Peche Art Gallery the Artist will be registered with Peche Art for the consigning of any number of works of art for gallery display for a minimum of 14days and a maximum of 93 days per item as per the terms of the consignment agreement overleaf.*

**GALLERY CONSIGNMENT AGREEMENT**

This consignment agreement is between : Peche Art Limited ( henceforth referred to as the ‘Gallery’) of 55 Sandgate High Street, Folkestone, Kent CT20 3AH and the consigning Artist / Photographer / Creator of Fine Art ( henceforth referred to as the ‘Consignor’ ) as undersigned.

In accordance with this agreement the Gallery undertakes to take receipt of the consignment from the Consignor with a view to exhibiting and selling the consigned item(s) or returning them if not sold after an agreed period.

On taking receipt of consigned item(s) The Gallery will give the Consignor a written receipt. The condition of the consigned item(s) being recorded, with The Gallery undertaking to reasonably maintain the consigned item(s) in the same condition as consigned, until the consigned item(s) are sold or returned to the Consignor.

The Gallery on selling the consigned item(s) agrees to pay the Consignor the agreed amount per item within 28 days from the date of sale. The sale being complete when the consigned item(s) are removed from the Gallery and passed to the seller in return for payment of the consigned item(s) at a price set by the Gallery.

The consigned item(s) when received by the Gallery will be exhibited to be sold at a price set by the Gallery which may be above or below the price agreed per item payable to the Consignor for the sale of the item(s) at the date undersigned. The amount payable to the Consignor by the Gallery on sale of the consigned item(s) will not deviate from the scheduled amount as per this agreement at the date undersigned.

For: Item(s) valued for sale by the Gallery the Consignor will receive 70% of the sale proceeds payable by the Gallery.

As the Gallery wishes to encourage young artists, a special dispensation is offered to Consignors less than 25 years of age and in full time education, at the discretion of the Gallery, for the sale of any item(s) they consign they will receive 75% of the sale proceeds payable by the Gallery.

The duration of the consigned item(s) will be for an initial 93 days with an option by both Consignor and the Gallery at the end of this term to agree any further consignment extension.

Delivery, and if not sold, collection of the consignment to and from the Gallery is the responsibility of the Consignor with no cost born by the Gallery. Consigned item(s) will only be accepted by the Gallery if consigned in a condition suitable for exhibiting and sale. On delivery of the consignment and formalisation of this agreement, as undersigned, the Gallery will commence responsibility for the item(s) consigned. The Gallery will provide adequate insurance with respect to loss or damage cover for the consigned item(s) whilst in their possession at no cost to the Consignor.

Ownership of the consigned item(s) remains with the Consignor until the point of sale by the Gallery. The creative copyright of the item(s) will remain with the Consignor subject to the undersigned declaration:

**(a) I as the Consignor of the item(s) as listed, declare that I \*am/ act for the creator of the item(s) consigned and as such can state no other person(s) has claim on the listed consigned item(s) relative to authentication or property ownership. And...**

**(b) I agree as Consignor to have the consigned item(s) photographed on receipt by the Gallery for purposes of insurance, sales promotion and recording the true condition of the item(s) consigned.**
